## **TSCA Lesson Grant Information/Requirements:**

1. Clubs that receive lessons grants are at the discretion of the TSCA Board.
2. Grants are a maximum of \$250.00.
3. The Club must be located in and conduct dances/lessons in Texas.
4. Application for a grant in no way obligates TSCA to award a grant to the applicant.
5. Lessons' instructors must be a member of the Texas State Callers' Association (TSCA).
6. Lessons must cover ALL the calls on the CALLERLAB Mainstream Program.
7. The lessons must have a minimum of 8 (eight) students in the class (a student is defined as a person who has paid for the class).
8. Clubs receiving grants are not eligible to reapply until 3 years after receiving the grant.
